B. Pursuant to SEBI circular no. SEBI/HO/IMD/DF3/CIR/P/2020/194 dated October 05, 2020, the investors are hereby requested to note the following changes wef April 01, 2021:

1. RENAMING OF DIVIDEND OPTIONS:

The names of the Dividend Payout Option and Dividend Reinvestment Option of all the Schemes of JM Financial Mutual Fund will be changed to "Payout of Income Distribution cum Capital Withdrawal Option" and "Reinvestment of Income Distribution cum Capital Withdrawal Option" respectively as explained in the following examples:
